BOARD OF GOVERNORS MEMBERSHIP CONDITIONS AND REQUIREMENTS

1. Members shall be designated as Governors.
2. Minimum age of 21 years is required for consideration of membership in the Committee of 300 of Long Beach, Inc.
3. Members are required to wear approved and designated official C-300 attire when participating in sanctioned events.
4. Members shall attend a minimum of six (6) regularly scheduled Board of Governors meetings held on the 3rd Wednesday of designated months.
5. Members are required to be an active participant in at least one (1) working committee. This will involve attendance at meetings of that committee and taking an active role in the projects of that committee.
6. Members are expected to conduct themselves in a manner consistent with the goals and the objectives of the C-300 while representing the C-300 organization. Individual representation is not permitted unless that member has been duly elected or appointed to that capacity. Members will refrain from any act, which may be deemed as detrimental to the C-300 organization or its members.
7. Members are encouraged to support fund raising efforts of the Grand Prix Foundation and expected to participate in C-300 and GPALB activities including designated community related venues, i.e. holiday parades, etc.
8. Members are required to annually staff a minimum of two (2) Grand Prix Association of Long Beach sanctioned events inclusive of one (1) auto show promotion.
9. Members must have fulfilled the outlined requirements of and be a member-in-good standing of the C-300 in order to qualify for race weekend credentials. Qualifying members will be issued any necessary credentials to facilitate the performance of assigned weekend duties. Qualifying first year members will have grandstand assignments. Certain assignments may prevent or interfere with actual viewing of the event.
10. All printed material including membership roster information is exclusive to the Committee of 300 of Long Beach, Inc. and shall not be used for any other purpose.
11. Annual dues for the first year of regular membership are \$125.00, with a renewal fee of \$100.00 on July 1 of each fiscal year thereafter. Dues are not tax deductible. Membership is subject to review and approval by the Membership Committee and the Board of Directors.
12. I understand and agree that my membership may be revoked if I fail to meet the above requirements, subject to the procedures and guidelines contained in the Bylaws of the Committee of 300 of Long Beach, Inc. Should my membership be revoked, I agree to return all properties and other indications of membership upon demand by the President or a duly appointed representative.
